Here are some new changes in V30, I have also included some of the 29 changes as well.

**Has Fix for POS quotes not replacing stock.
Data corruption safety's built in.
The 2024 tax tables are now up to date in version 30.
and more see below...**

WAGES : The 2024 tax tables are now up to date in version 30.

The wages program is STP2 which is compulsory to use for the ATO.

Super Reporting can now be reported in Bizz Wizz though the Ozedi portal in line with changes soon to be passed by the ATO.

Invoicing , Orders and phone lists

Customers and suppliers can now search for detail on all 5 contacts for a company.

Note v29 only did this in invoicing.

The quantity column on an invoice printout can now be placed before or after the description column.

Retail, Trade, Bulk & Wholesale - Can now be changed on an Invoice if items are pulled from stock. You can Choose " All " or " Next items only ".
